## Road Signage and Posts:

- The delivery of 10 sign posts and road sign holders is still pending.
- New road signs have been received and are awaiting the installation of the sign holders.
- An additional 10 horse post tops are also on order.

#### Trail Maintenance:

- Quarterly trail maintenance is scheduled for April.
- Maintenance efforts are intentionally minimized during the early months of the year due to slower vegetation growth.
- Planning also takes into account potential stormrelated issues later in the year, allowing for flexibility in scheduling.

### Park Maintenance:

- Park fence cleaning is scheduled for June.
- · The park gate has been successfully repaired.
- · Repairs to the park sign are currently underway.
- · Park tree trimming is scheduled for June.


Reminder

- Announcement of the 2025 Board of Directors: Board seats are elected annually. The 2025 Board of directors will be: Tony, Nikki, Jack, Hannah, and Chris.
- Carryover Vote: The membership present and by proxy unanimously voted in favor.
